Mission Church Reports: Craig Beaton. Church of the Good Shepherd. They currently have around 50 on Sunday mornings. A family from the Mennonite faith is preparing to join. Preparing to bring on 2 elders and 1 deacon possibly in January. These are all solid men who have been leading the Church. A few folks in the area fill the pulpit. Craig B. tries to fill the pulpit quarterly. If no pastor then one of the three teaches. Baptism issues to be worked out

Lakeland – Saints doing well. Uri ordained two men (Joe McGuire deacon and Mike McQuade as an elder) Jim Fitzgerald and RC Jr fill the pulpit frequently. Motion 12/08/11:05 That Athanasius Presbytery amend our Book of Procedures to state that local churches should have unordained pastoral candidates submit to the presbytery ordination exam prior to extending a call to them.... (Craig Beaton, second, carried 7-2-2)

Discussion. Craig Rational – It has become common to extend calls before ordination. This practice has led to difficulty in some ordinations. Recommend that if any Church desires to call an unordained man that the Church arrange for an examination prior to extending a call.

Mickey speaks in favor.

Wedgeworth – in favor our presbytery has seen this as a pattern.

Rich Lusk - in favor. Our local church closed this within our constitution.

Greg Parry – Does the constitution stipulate what the requirements of exam are? (Constitution reviewed)

Stoer - In favor, but want further discussion on the details

Expenses for this presbytery 700 dollars Monies to Christ pres.

Mickey requests that the pres. Forgive him for his failures in mentoring Ben Rossell. Granted

Herman Gunter – Background, Graduated mdiv 1975... Chaplain at boys ranch for 3 years. Business since then. Married with 7 children all communing members of Churches. First Pres of live oak, after leaving boys ranch became very active.

Part of several church splits. PCA formed... Preached over 300 sermons at various churches. First Pres split from PCUS, as independent then PCA as Community PCA. Part of a discipline process over theonomy. Moved to Grace Pres in Madison after 6 years. In the providence of God we were renting the First Pres. The PCUS Live Oak was closing First Pres and chose to sell First Pres, Community PCA offered 1/3d the asking price and it was accepted. June bought the property. They have begun to renovate the property (6000 sq. ft) church has existed there since 1871. In October 2012 they began to have services. Very grateful to BH and Trinity

Evening services with high liturgy. Sing the scriptures with antiphonal worship.

His desire is to be part of a church with weekly communion with wine.

Are the sessions supportive? Yes.

Barry Wells, grew up in military family... 2001 – 2011 with AF as chaplain. Came into contact with liturgy folks and read the Lord's Service and attended worship at Trinity. Part of CREC Maryland. Covenant Heritage in VA, w/Steve Hemeky. Hold to Covenant Communion and looking to serve as a full time ARP presbytery. Ordained in 1998. Looking for trinity pres to endorse. Trinity is looking at joining National association of Evangelicals to sponsor.

Jim Hunter – Independent Presbyterian in Birmingham, got involved in the Episcopal Church through youth group. Had a call to ministry since 7 years old, felt at a lesson and carols service. Rhoads College, religion. Not time going to seminary. Decided to go into business.

1988, continuing Church movement in the Episcopal Church. Been part of many churches. Looking for a church Reformed and Evangelical Church in keeping with J C Ryle, Cumming and Chaney. Desire to rekindle such a church in the US.

Differences with my brothers in the CREC on what that might look like.

My hope and prayer is to allow me to plant such a church.
