A. King's Cross Church – Wenatchee, Washington

MISSION CHURCH OF TRINITY CHURCH, KIRKLAND, WASHINGTON

- 2nd CREC church in Wenatchee, Washington
- 4 elders on the board: 1 local (Gene Helsel) and 3 pro tempore
- The church is a mission of Trinity Church in Anselm Presbytery, however, due to its location it will be seated as a full member church in Knox Presbytery when particularized.

B. Presentation of Candidate Church from Nikolayev, Ukraine

- San Sanych introduced Vladymyr Mykyta from Christian Evangelical Reformed Church in Nikolayev, Ukraine
- Rivne Biblical Church is the sponsoring church
- Discussion ensued with the presbyters, highlighting...
 - Church Details
 - The church was started in 2004, and officially recognized by the Ukrainian government in 2006
 - The church is an "independent" Presbyterian church they refer to themselves as Presbyterian because they hold to the Westminster Standards
 - They have 4 elders
 - They have 2 deacons
 - They want to join the CREC because they believe in the community of the saints as stated in the Apostle's Creed. They want to have an extended relationship with the saints and to be part of a movement to serve and be served.
 - They practice paedo-communion.
 - Information on Vladymyr Mykyta
 - He has a wife and two daughters, who are faithful. His oldest daughter is
 17.
 - His motto: Relationship in ministry; ministry through relationship
 - After he graduated seminary, he was ordained by the Korean Presbyterian
 Church not charismatic

- Motion: To seat Christian Evangelical Reformed Church as a candidate church
 - o Moved: San Sanych
 - Seconded: Garry Vanderveen
 - Discussion
 - Dave Hatcher reminded us that once they are seated as a candidate church they have two years to become a full member church and the next two presbytery meetings will be in the United States. San Sanych is responsible to make sure that they go through the CREC constitution and memorials.

X. OLD ANSELM BUSINESS

A. Presiding Minister Report

- Dennis Tuuri presented his report
- He was called on 4 times to give counsel and advice to churches in the presbytery
- Only one action taken that requires ratification at Presbytery
 - Selection of Garry Vanderveen and Bogumil Jarmulak as delegates to the Houston Summit Meeting Called by Council in 2013
 - o This matter will be taken up under Agenda Item X.C.

B. ASSIGNMENT OF MEMORIALS TO ANSELM MEMBER CHURCHES FOR POSSIBLE REVISION

- Dave Hatcher explained that at the previous Anselm Presbytery a vote was taken for a
 committee to be formed to examine each of the memorials for recommendations on
 whether to leave it as is, make changes to it, or remove it. This did not happen, so it is
 proposed that Presbytery act as a Committee of the Whole and assign memorials to specific
 churches for those churches to evaluate and make recommendations to Presbytery.
- Dean Hellekson asked a question about the role of the memorials. Dave Hatcher explained
 that the memorials are non-confessional and require assent to be given to them or
 exception taken with them by any church that is admitted to the CREC.
- Dave Hatcher called for volunteers for assignments of these memorials. Those who volunteered were:

The term "evangelical" in our documents is not to be exclusively defined by modern ideas which insist on particular definitions or philosophies of "regeneration." Rather, our documents use of "evangelical" is to be understood in the broad sense in which Martin Luther (and reformed churches ever since) have used the term - as a designation of Protestantism and our adherence to Sola Scriptura and Solus Christus.

Memorials state the position of the CREC on issues on which a confessional statement has not **yet** been made. Memorials are contained in the Book of Memorials and are incorporated by reference into this Constitution.

Motion D:

Proposed new Memorial on Socialism

Covenant Bible Church of Chugiak, Alaska, overtures Anselm Presbytery to overture the CREC Council to adopt the following new Memorial.

Memorial Concerning Socialism

I. The Communion of Reformed Evangelical Churches affirms that Socialism is an error and a departure from Christian teaching.

A. Formal ground:

Too many professing Christians, including those in the CREC, are unfamiliar with the anti-Christian nature of the economic system of Socialism and, as a result, suffer under it and either explicitly or implicitly promote it.

B. Material grounds:

- 1. Socialism is in conflict with man being the image bearer of God, who as such is a responsible creature individually accountable to God. The Christian may not shun any facet of his God-ordained personal and covenantal responsibilities by shifting them to the state.
- 2. Socialism is in conflict with the First Commandment in that it gives priority to the State above God as the supreme authority over man. God is the great benefactor and not the State. Socialism contradicts the Biblical teaching by making the State the distributor of wealth and the regulator of life. Under Socialism, men are made by circumstance to look to the State rather than to Divine Providence as the source of their daily material sustenance.
- 3. Socialism is in conflict with the Eighth Commandment which insists upon the legitimacy of private property, forbids any form of stealing the property of others and demands of the individual faithful stewardship of his own property and the protection of the property of others.
- 4. Socialism is in conflict with the Tenth Commandment which forbids all coveting of the neighbor's possessions and all notions of statist redistribution of wealth which is the key tenet of Socialism.
- 5. Socialism advances the idea of centralization of power which is the very purpose of Satan, illustrated by the beasts out of the sea and the earth in Revelation 13. Further, Socialism advocates "one world" under the dominion of man in the spirit of anti-christ, which Christians may not advocate or support in any form.

II. The Communion of Reformed Evangelical Churches shall do its utmost to disseminate knowledge of the Biblical, Christian position regarding Socialism throughout the CREC in whatever way Council believes to be most effective.

Grounds:

- 1. The ubiquitous presence of Socialism in Europe and the strong drift toward Socialism and state welfarism in the United States and Canada has rendered the church unconsciously vulnerable to departure from the Biblical position articulated above.
- 2. The current accelerated adoption of socialist and state welfarist measures in the United States and Canada makes it a matter of paramount importance that our people in North America be aware of the CREC's position and see Socialism for what it is, a diabolical evil.
- 3. Christians outside North America have, in many instances, little experience with systems that are not thoroughly socialistic, and need instruction and encouragement from the Church of Jesus Christ to work toward a more Biblical economic system in their respective parts of the world.
- III. The Communion of Reformed Evangelical Churches shall strongly encourage all ministers, elders and deacons and others in church leadership to be sincerely committed to the CREC position on Socialism, that they strictly adhere to this position in their church life and private conduct and that they faithfully champion this position and warn church members against all departures from it.

Grounds:

- 1. Church leaders have a great influence upon the membership of the CREC and its individual churches.
- 2. Church leaders play a strategic role in shaping and molding the future thinking of the membership of the CREC by virtue of their influence on covenant young people in CREC churches.
- 3. Church leaders function as an important segment of the total Christian witness which God requires the church to bear in this time of economic darkness.
- Moved: Jack Phelps announced he would not be moving the proposal at this time, but requested that the body discuss the matter.
- Dave Hatcher declared the motion withdrawn and opened the floor for discussion of the proposed memorial
- o Discussion ensued.
- Jack Phelps indicated that CBC will consider and incorporate the input, and send out a new draft prior to the next stated presbytery meeting.

E. MOTION BY CHRIST COVENANT CHURCH, LANGLEY, BC

Motion E:

That the following subscription formula be added to the Constitution of the CREC:

- (1) I wholeheartedly and willingly acknowledge before God that the Holy Scriptures, consisting of the Old and New Testaments, are the Word of God and the only rule of faith and conduct.
- (2) I further wholeheartedly and willingly acknowledge before God that I believe the doctrines contained in the Three Forms of Unity (apart from the approved exceptions noted below), are a faithful interpretation of the teaching of the Word of God, and to all these doctrines, I subscribe and confess to be my own understanding of the doctrine of the Word of God.
- (3) In making this subscription I understand that the Three Forms of Unity are not on a level with the Word of God, and thus I do not declare that the statements of doctrine in them are necessarily formulated in the best manner, or that they are exhaustive statements of the doctrines confessed, or that every teaching of Scripture is dealt with or every error condemned. Furthermore, I do not declare that the Scripture references and allusions, incidental remarks or the theological deductions which some may draw from the doctrines set forth in the confessions are binding. Nevertheless, I subscribe as previously stated to the doctrines intentionally conveyed by the Three Forms of Unity, because they are derived from the Holy Scriptures and in agreement with them.
- (4) I pledge myself faithfully to adhere to the doctrines of Three Forms of Unity and to reject all doctrines or opinions whatever that are contrary to or inconsistent with them. I recognize that I am not to decide for himself or for my congregation what is and what is not a doctrine confessed in the Three Forms of Unity. In the event that such a question should arise, the decision of the assemblies of the CREC shall be sought and followed.
