## VIII. Sponsorship of Grace Covenant Church – Gibsons, BC

PM Phelps gave a brief history of Grace Covenant's relationship with churches in the CREC.

Pastor Kloss expressed the intention of Redeemer Church of Lynnwood, WA, to adopt and support Grace Covenant Church as a mission church with Pastor Kloss serving as an elder *pro tempore* on the mission's session. Grace Covenant Church is now recognized as a CREC mission church under the care of Redeemer Church, Lynnwood.

**Note**: This is an unusual situation. The CREC Book of Procedure provides that a mission church of a CREC member church automatically has CREC mission status when the conditions for forming a mission church have been satisfied (Article IV.3.d.i and Article IV.3.a). In the case of Grace Covenant Church, both of its previous sponsor churches left the CREC, one after another. Grace Covenant Church sought a new sponsor church, but no formal action had taken place to satisfy the need. Hence, the item was placed on the Anselm Agenda for 2018. Redeemer Church stepped forward to address the matter and adopted Grace Covenant Church, announcing the fact to Anselm Presbytery.

#### IX. Consideration of New Member Church

Reformed Church of St. Andrew – Pidhaychyky, Ukraine

Candidate church sponsored by Reformed Church of Christ the Savior, Rivne, Ukraine.

Pastor San Sanych and PM Phelps explained the history of the church and the situation that prevents the pastor, Volodymyr Yakubovsky, and other elders from obtaining US visas, hence disallowing a vote on the church's candidacy.

#### Motion 18/09/26:1

Pastor Jarmulak moved to extend the candidacy of Reformed Church of St. Andrew for one more year, to the date of Anselm Presbytery's 2019 Stated Meeting. Pastor Owen seconded. Motion carried without objection. (21:0:0)

**Note**: This candidacy was previously extended twice, in 2016 and 2017. Therefore, this motion required a 2/3 vote of Presbytery to be extended again (ref: Constitution Article III.L).

## X. Reports from Ordination Committees

Troy Martin Committee (Appendix A)
 Pastor Owen read the examination committee's conclusion.

"Based on his written and oral examination, we recommend Troy Martin for ordination to the ministry. As part of this recommendation we ask that Troy enroll in formal training in Hebrew, Greek, and biblical counseling. We appreciate the full-time pastoral ministry Troy is engaged in at the church, do not want to burden him in a way that takes away from that work, and therefore recommend he complete this course of study over the next three years. Perhaps it would be helpful to enroll in one class per year. We believe these classes will bear long-term fruit in Troy's ministry and the life of the church. Please inform the ordination committee chair Jerry Owen when Troy has enrolled in these classes."

The examination committee moves that Anselm Presbytery agree to this recommendation of Troy Martin to the session of Trinity Covenant Church – Santa Cruz, CA. Motion carried without objection. (21:0:0)

## 2) Aaron Fudge Committee (**Appendix B**)

Pastor Craw read the examination committee's conclusion:

"The committee that examined Mr. Aaron Fudge for ordination recommends his ordination with the provision that he complete his Hebrew studies and submit a Hebrew exegetical paper to the session of Christ Church, Santa Clarita, CA within the next 24 months."

#### Motion 18/09/26:3

The examination committee moves that Anselm Presbytery agree to this recommendation of Aaron Fudge to the session of Christ Church – Santa Clarita, CA. Motion carried without objection. (21:0:0)

PM Phelps expressed thanks for the privilege of serving Anselm Presbytery and explained the three ratifications requested in the PM Report.

**Note**: It was pointed out that the sequence of ratifying the PM's appointments of Ordination Examination Committees, the oral exams on the floor of presbytery and the vote to recommend men for ordination should be addressed in future agendas for Anselm Presbytery.

Pastor Hatcher moved to ratify all three items included in the Anselm PM Report. Pastor Stoos seconded. Motion carried without objection. (21:0:0)

Pastor Jarmulak moved to ratify the appointment of a Presbytery Court to examine the complaint. Pastor Kloss seconded. Motion carried without objection. (21:0:0)

Pastor Jarmulak moved to ratify the court's Report of Findings on the complaint. Pastor Kloss seconded. Motion carried. (19:0:2)

**Note**: During discussion clarification was provided that actions of the RCC *pro tempore* Session were the subject of the court's review, not the actions of the person who filed the complaint.

PM Phelps recessed the meeting at 9:52 am to the call of the chair.

PM Phelps gaveled the meeting back to order at 10:15 am.

Motion carried without objection. (21:0:0)

3. Pastor Craw moved to approve PM Hurt's action to gather demographic information from CREC churches. Pastor Smith seconded. Motion carried. (19:2:0)

Note: Elder Barnard asked for clarification on the wording in Appendix E, especially

what is "pertinent" information on pastoral issues. The question will be referred to the PM of Council.

#### Motion 18/09/26:10

4. Pastor Stoos moved to approve PM Hurt's CREC Statement on Sexuality. Elder Barnard seconded. Motion carried without objection. (21:0:0)

## CREC List Rules Committee Report

After discussion, the delegates encouraged one another to reach out directly to the committee with their concerns and to remember these are proposed guidelines rather than rules.

PM Phelps recessed the meeting at 11:25 am to the call of the chair.

PM Phelps gaveled the meeting back to order at 11:46 am.

Proposal for CREC Examination and Ordination procedures.

Discussion of this matter was lengthy and complex. A summary will be provided to the Council Committee and to the PM of Council.

Pastor Kmiec prayed.

PM Phelps recessed the meeting at 12:30 pm until the following day.

## September 27

PM Phelps gaveled the meeting to order at 9:05 am.

Singing led by Pastor Hatcher (Jesus Shall Reign)

Pastor Jarmulak led in prayer.

#### Motion 18/09/27:1

Pastor Stoos moved an amendment to the Agenda for the election of delegates to council. Pastor Owen seconded. Motion carried without objection. (21:0:0). PM Phelps indicated this would be added to the Agenda as new Item XIX, with following items renumbered accordingly.

The body returned to a consideration of Item XIV from the previous day.

Social Media Committee

## Motion 18/09/27:2

Pastor Jarmulak moved that the PMoC be requested to add Pastor Smith to the Social Media Committee. Elder Barnard seconded. Motion passed without objection. (21:0:0)

Pastor Smith will keep Anselm updated via the email list.

## **XV.** Anselm BOP amendment proposal (Appendix G)

Covenant Bible Church presented a proposal for an amendment to the Anselm Book of Procedures, enabling the creation of a Provisional Presbytery in Europe and the Western Pacific.

PM Phelps explained the background of the proposal, including Anselm's multi-year discussion about the future formation of an Asia/European presbytery. He also clarified the proposal's relationship to the CREC Constitution and Book of Procedures.

Pastor Jarmulak moved that Anselm Presbytery adopt the proposed amendment to Anselm's Book of Procedures set forth in Appendix G to provide opportunity for a Provisional Presbytery to be established in Europe and Japan. Pastor Stoos seconded.

After much discussion on the motion, PM Phelps recessed the meeting at 10:43 am to the call of the chair. Delegates from churches affected by the proposal announced their intent to caucus about the matter during recess.

PM Phelps gaveled the meeting back to order at 11:14 am and reverted up the agenda to Introduction of Guests. He then introduced hotel Events Coordinator Bernard Morris who helped CBC arrange the venue for Anselm's meeting. The body thanked Mr. Morris for his assistance and gave him an enthusiastic round of applause.

Anselm Presbytery returned to regular order with *Motion 18/09/27:3* pending before the body.

#### Motion 18/09/27:4

Pastor Hatcher moved that Appendix G be amended to include a representative from an Anselm church outside the Provisional Presbytery be present at stated meetings of the Provisional Presbytery. Pastor Jarmulak seconded. Motion carried without objection. (21:0:0)

**Note**: During discussion there was consensus agreement that expenses related to the representative's travel would be covered by donations from Anselm Presbytery.

## Motion 18/09/27:5

Pastor Hatcher moved that Appendix G be amended to require that Provisional Presbytery meetings be conducted in English (translators must be present as set forth in CREC Book of Procedures Article VI). Pastor Jarmulak seconded. Motion carried without objection. (21:0:0)

Pastor Jarmualk moved that Appendix G be amended to include a time limit on the life of the Provisional Presbytery before re-evaluation and a vote to re-authorize its existence. Pastor Hatcher seconded. Motion carried without objection. (21:0:0)

**Note**: During discussion, Elder Unger asked if the proposed provisional presbytery could admit candidate churches. PM Phelps clarified that the current language of Appendix G in conjunction with the rules of the CREC Book of Procedures would not allow a Provisional Presbytery to admit churches. However, he suggested the possibility that a Provisional Presbytery could vet and recommend a Candidate Church, requesting an *ad hoc* meeting during which Anselm could vote on a proposal to admit a candidate church.

#### Motion 18/09/27:7

Pastor Hatcher moved that Section 2.a.ix be removed from the Appendix G proposal. Elder Barnard seconded. Motion carried without objection. (21:0:0)

**Note**: Pastor Jarmulak raised the question of to whom a member of the Provisional Presbytery should address concerns if mediation were needed under Section 2.a.viii. The answer is found in the language of Section 2.a.viii, which specifies that consultation is required with the Presiding Minister of Anselm Presbytery. Normally, the channel would be through the Presiding Minister of the Provisional Presbytery to the PM of Anselm. Section 2.a.viii is also clear that only voluntary mediation is within the purview of the Provisional Presbytery. Required mediation or non-binding arbitration is reserved to Anselm Presbytery and is not delegated to the Provisional Presbytery (see Section 2.b.vi).

There being no further debate nor amendments offered, *Motion 18/09/27:3* as amended is before the body. Motion carried. (20.1.0)

#### Motion 18/09/27:8

Pastor Jarmulak moved to establish a Eurasian Provisional Presbytery of Anselm Churches until the 2020 CREC Council meeting. All Anselm churches within the geographic boundary are invited and encouraged to participate. Pastor San Sanych seconded.

Elder Hyink moved to amend the motion to read one year so that the Provisional Presbytery would be regulated in 2019. Elder Unger seconded. Amendment failed. (2.17.0)

There being no further debate nor amendments offered, *Motion 18/09/27:8* to create a Eurasian Provisional Presbytery is before the body. Carried without objection. (21:0:0)

## XVI. Election of Presiding Minister of Anselm Presbytery (Nominee: Pastor Hatcher)

One nomination was received and appears on the agenda. PM Phelps opened the floor for further nominations. Hearing none, nominations were closed.

#### Motion 18/09/27:10

The name of Pastor Hatcher, as the sole nominee for Presiding Minister of Anselm Presbytery for the period 2018-2021 is before the body. Motion carried unanimously. (21:0:0)

Public thanksgiving was accorded to Pastor Hatcher for his prior service and his willingness to serve Anselm again as Presiding Minister.

# XVII. Election of Presiding Minister *pro tempore* of Anselm Presbytery (Nominee: Pastor Owen)

One nomination was received and appears on the agenda. PM Phelps opened the floor for further nominations. Hearing none, nominations were closed.

## Motion 18/09/27:11

The name of Pastor Owen, as the sole nominee for Presiding Minister pro tempore of Anselm Presbytery for the period 2018-2021 is before the body. Motion carried unanimously. (21:0:0)

Public thanks was accorded to Pastor Jarmulak for his past service and to Pastor Owen for his willingness to serve Anselm as Presiding Minister *pro tempore*.

Motion 18/09/27:14

Pastor Jarmulak moved to nominate Pastor Phelps as a delegate to Council. Pastor Stoos seconded. Motion carried unanimously. (21:0:0)

Pastor Jarmulak requested that delegates recognize and thank Pastor Phelps for his years of service to Anselm Presbytery. Pastor Phelps expressed gratitude for the opportunity to serve and thanked his wife, Debra Phelps, for her support and patience. Pastor Jarmulak prayed.

Presbytery acknowledged Elder Unger's last attendance as a delegate to Anselm Presbytery. Due

to an employment change, Elder Unger will now be attending a CREC church in another

presbytery.
