2:01 p.m.: The meeting resumed with the singing of Psalm 92 and Psalm 11.

2:07 p.m.: Consideration of candidate churches.

Mr. Bostrom moved to extend the candidate status of Covenant Christian Church, Greenville, MI for another year. Mr. Evans seconded and the motion passed.

Mr. Osinga moved to extend the candidate status of Christ Covenant Church of Chicago for another year. Mr. Nolder seconded and the motion passed.

Mr. Sauder moved to extend the candidate status of Reformed Presbyterian Church, Tyumen, Russia for another year. Mr. Nolder seconded and the motion passed.

2:51 p.m.: Presbytery Discussion Topics

2:51 p.m.: Mr. Evans initiated a discussion on ruling elder/elder training in small churches. Suggestions from the discussion were to 1) Think about having pro tem elders for a defined term rather than allow them to serve indefinitely. 2) Develop an elder training protocol to share with other churches. 3) Realize that the "elder qualification bar" can be set higher than Scripture, and that current elders might need to address this perception by members in the church.

3:39 p.m.: By common consent, the meeting recessed for a break.

3:52 p.m.: The meeting reconvened.

3:52 p.m.: Mr. Evans initiated a discussion on pastoral authority in counseling situations. A summary of the discussion was that the session should be unified when requiring something on the basis of wisdom. Various means (decided in wisdom) can be required in order to reach a clear biblical end. Discussion with other churches is often helpful

4:49 p.m.: The MP recognized visiting delegate Greg Lawrence for comments and questions.

5:03 p.m.: Mr. Sauder moved that the next annual meeting of Tyndale Presbytery be held in Springfield, MO with date to be announced. Mr. Bushong seconded and the motion passed.

5:06 p.m.: Mr. Nolder moved that the date for the next annual meeting of Tyndale Presbytery be set for Monday and Tuesday, September 20-21, 2010. Mr. Harlan seconded and the motion passed.

5:08 p.m.: Mr. Sauder moved that Tyndale Presbytery expresses its sincere gratitude to Trinity Evangelical Church in Larwill, IN. for being so gracious and hospitable to us, for providing a comfortable meeting place, for refreshing us with delicious food, beer, and cigars and for making preparations for such a successful and enjoyable presbytery meeting.
