Executive session voted unanimously to recommend Tyler Hatcher to Trinity Church for ordination.

Andrew Richardson invited Michael Kloss of Emmanuel Church, Lynnwood, WA to come forward for

examination. Following the committee examination, questions were opened to the floor.

Executive session was called for deliberation.

Executive session voted unanimously to recommend Michael Kloss to Emmanuel Church for ordination.

XII. Examination of Bo Cogbill

Dave Hatcher invited Bo Cogbill and Gary Barnard to introduce Bo Cogbill.

Report on Bo Cogbill's background. Questions were opened to the floor.

Motion - Jerry Owen moved to receive Bo Cogbill into the CREC as an ordained minister, previously

ordained in Christ Covenant Church of Mesquite, Texas. Bogumil Jarmulak seconded.

Motion passed unanimously.

XIII. Provisional Presbytery Report – Bogumil Jarmulak

Bogumil Jarmulak summarized his provisional presbytery report and gave an update on the provisional

presbytery meeting earlier this week. Dave Hatcher opened it up to the floor for discussion.

Following discussion, Bogumil Jarmulak suggested the possibility of waiting another three years for any

of a number of reasons. There was no strong vocal consensus to do so.

Dave Hatcher suggested to take a poll to gauge the feelings of the presbytery on splitting.

Bogumil Jarmulak suggested that the provisional presbytery should meet for two or three days to discuss

fears and questions about proceeding with the provisional presbytery.

Dave Hatcher asked if there was anybody here who was opposed to starting a new presbytery in 2020.

Oleksandr Orlov-Koshchavka opposed until issues resolved. No specific "issues" or charges were

brought up on the floor. Dave Hatcher exhorted the delegates to make sure there were no unresolved

offenses between elders or any churches.

Dave Hatcher asked for a poll to gauge who was enthusiastic about starting a European presbytery. 17/25

delegates polled were enthusiastic.

XIV. Consideration of New Member Church

by Reformed Church of Christ the Savior, Rivne, Ukraine.

Motion - Oleksandr Orlov-Koshchavka moved to bring the Reformed Church of St. Andrew into full

membership. Motion seconded by Michael Kloss.

Motion passed with one abstention.

Volodymyr Yakubovsky took the vows of membership.

XV. Report from Ordination Committee (on Hatcher and Kloss)

1. Tyler Hatcher

Jerry Owen for the committee recommends to Trinity Church that Tyler Hatcher

be ordained.

2. Michael Kloss

Andrew Richardson for the committee recommends to Redeemer Church that

Michael Kloss be ordained with reservation: recommendations were given on the

floor and in writing to the session of Redeemer Church to have Michael pursue

study in biblical languages along with other recommended reading.

XVI. Discussion Request - Reformed Church of Christ the Savior - Rivne, Ukraine (Oleksandr

Orlov-Koshchavka)

1. Ukraine Churches have the opportunity to join with several Lutheran churches in forming

(reviving) an ecumenical fellowship/denomination in Ukraine. There are possible pros

and cons being discussed and the churches seek the counsel of the Presbytery.

Dave Hatcher invited Oleksandr Orlov-Koshchavka to give a brief overview of this opportunity.

Questions were opened to the floor.

Following discussion, Dave Hatcher summarized the view of the presbytery: the presbytery advises the

Ukrainian churches to move slowly, considering the options and red flags present in the opportunity.

XVII. A - Proposals from Evangelical Reformed Church in Poznan, Poland

Motion- Bogumil Jarmulak moved to send the following proposal to the Constitutional Revision

Committee. Seconded by Jerry Owen.

- 1. Add the following to BOP Art. III.2: Every church, before it is received as a new member church, must present its constitution to the presbytery at least a month before the scheduled meeting of the presbytery at which it is to be received as a new member.
 - i. Rationale: A look at the church's constitution will provide a better knowledge of the church to be received as a new member.

Motion passed unanimously.

Motion - Bogumil Jarmulak moved to send the following proposal to the Constitutional Revision Committee. Gary Barnard seconded.

- 2. Add the following to Constitution Art. III.D.1: e) Each member church must include in its governing documents the following provision: "If a local church wants to remove a pastor from the office it should inform the Presiding Minister of Presbytery about its intentions and seek his advice at least one month in advance. In the meantime, the pastor may be suspended or put on a leave of absence in accordance with the provisions of the church's constitution."
 - i. Rationale: Removing a pastor from the office is a serious business. Therefore, it seems to be wise to seek advice from the PM before the final decision is made. Note that it is only advice, and not approval. The PM can help the local church to make a wise decision and to make it wisely.

Motion - Following discussion, Bogumil Jarmulak **moved to amend** the proposal to the following, and to send the amended proposal to the Constitutional Revision Committee. Andrew Richardson seconded.

1. Add the following to Constitution Art. III. D.1: e) The session of elders of each CREC church shall notify the Presiding Minister of Presbytery under the following circumstances: (...) Before dismissing a (pastor) or elder or calling for his resignation. [In the case of dismissal of a minister (pastor), the notification shall include the reason for the dismissal. It shall be done not later than one month in advance. The local church

session shall also seek the advice of the Presiding Minister in this matter. In the meantime, the pastor may be suspended or put on a leave of absence in accordance with the provisions of the local church's constitution.]

Motion to amend proposal passed without objection.

Motion passed. One abstention.

Motion - Bogumil Jarmulak moved to send the following proposal to the Constitutional Revision Committee. Michael Kloss seconded.

- 3. Add the following to Constitution Art. III.D.1: f) Each local church session must keep minutes of its official meetings.
 - Rationale: That seems to be obvious, yet there have been instances when sessions
 of local churches did not keep minutes of their official meetings. Minutes seem
 of special importance when conflicts or disagreements arise.

Motion passed unanimously.

Motion - Bogumil Jarmulak moved to send the following proposal to the Constitutional Revision Committee. Andrew Richardson seconded.

- 4. Add the following to Constitution Art. IV.A.2: In a case of a prolonged conflict within a local church session the Presiding Minister of Presbytery acting in agreement with the Presiding Minister pro tempore of Presbytery, and the Presiding Minister of Council can install an elder pro tempore as a member of the session to help the session resolve its internal strife. Such an elder pro tempore may stay a member of the session for the maximal period of one year. Before an elder pro tempore is installed in such a way, mediation between the members of the session is strongly advised.
 - i. Rationale: It seems that it is better to help resolve a conflict at an earlier stage rather than deal with its ugly results afterward. Sometimes mediation alone is not

enough to help solve deep conflicts. The presence of an additional elder can

change the dynamics within the session for better and help find a way out of the

conflict. (This would require a change of numbering of the whole section

IV.A.2.)

Motion failed. 1 in favor, 15 opposed, 4 abstentions.

Motion - Bogumil Jarmulak moved to send the following proposal to the Constitutional Revision

Committee. Gary Barnard seconded.

5. Add the following to Constitution Art. IV.A.2: Presbytery may officially request that a

local church remove its pastor or elder from the office in case of flagrant sinful behavior

or a gross violation of the CREC rules. 2/3 votes are required from presbytery.

i. Rationale: This would add an additional step in disciplining a runaway pastor

between admonishing him and removing the whole church. That would serve as a

warning to the local church before a more drastic and final decision is made

(removing the whole church from CREC). (This would require a change of

numbering of the whole section IV.A.2.)

Motion passed. 12 in favor, 4 opposed, 4 abstentions.

Recess: 2:45pm

Meeting called to order: 2:57pm

Motion - Bogumil Jarmulak moved to send the following proposal to the Constitutional Revision

Committee. Gabe Wetmore seconded.

6. Add the following to Constitution Art. IV.B.2: The Presiding Minister of Presbytery is

simultaneously the presbytery's delegate to the Council unless he opts out. In such a case,

another delegate is elected by the presbytery in his stead.

i. Rationale: This is the usual custom of our presbyteries. So, it would only be a formal recognition of an existing practice. Besides, a PM of Presbytery is usually the person enjoying the trust of the presbytery and also the person who knows the churches in the presbytery the best. Both can be very helpful in representing the presbytery at a council meeting

Following discussion, Bogumil Jarmulak requested to withdraw the motion. Motion was withdrawn with no objections.

Motion - Bogumil Jarmulak moved to send the following proposal to the Constitutional Revision Committee. Andrew Richardson seconded.

7. Change Constitution Art. IV.C.5:

Current reading: "Each Presiding Minister must be concurrently serving as a member of the local session. If a Presiding Minister ceases to serve in such a local office, then his term as Presiding Minister ceases at that time. Before his term is completed, a Presiding Minister may resign his position, or he may be removed by a three-fourths vote of the assembly."

Change to: "Each Presiding Minister must be concurrently serving as a member of the local session or be a retired CREC minister and a member of a local CREC church in good standing. If a Presiding Minister ceases to serve in such a local office, then his term as Presiding Minister ceases at that time. This provision does not apply in a case of retirement. Before his term is completed, a Presiding Minister may resign his position, or he may be removed by a three-fourths vote of the assembly."

Rationale: (1) It happens that active ministers or elders are not willing or able to serve as a PM due to their exhaustive responsibilities connected with their local church ministry. The suggested change would make the pool of candidates for PM larger and make it easier to elect a PM who is both able and willing to serve as a PM. (2) The suggested change would also make it possible to use the wisdom of experienced ministers after their retirement.

Motion passed. Two abstentions.

B. Proposal from Emmanuel Church, Bothell, WA

Motion – Jerry Owen moved to send the following proposal to the Constitutional Revision Committee. Troy Martin seconded.

Statement on Officer Qualifications

The CREC affirms the need for all officers to meet the biblical qualifications for office. An elder should be above reproach, the husband of one wife, self-controlled, sober-minded, respectable, given to hospitality, wise, able to teach, patient, temperate in his use of alcohol, peaceable, should lead his home well and have faithful children. Elders should not be quarrelsome, greedy, covetous or immature (1 Tim. 3:1-7, Tit. 1:6-9). A deacon should be honorable, the husband of one wife, wise and cautious in his speech, temperate in his use of alcohol, lead well in his home, not be greedy, and should hold the faith of Christ without reservation (1 Tim. 3:8-10, 12). While acknowledging that if the Lord marked iniquities no one would stand perfect, it is nevertheless important to uphold the qualifications as revealed in Scripture. Ordinarily, excluding exceptional circumstances, an officer whose marriage has failed or whose child is excommunicated will offer his resignation and it will be accepted by his session (1 Tim. 3:4-5, Tit. 1:6). When an officer remains in office after one of these events (or similar), the matter will be referred to the Presiding Minister of presbytery with a brief written description of the reasons in accordance with Article IV.D.2. The presbytery will respond to this report as appropriate. The local session is not judicially bound by the response of presbytery. If the presbytery recommends the officer's resignation and the local session does not abide by the presbytery recommendation, then the presbytery may or may not initiate proceedings according to Article IV.D.5.

Gabe Wetmore **proposed an amendment** to add "in his household" after "whose child" to the sentence beginning "Ordinarly, excluding exceptional circumstances."

Gabe Wetmore **proposed an amendment** to strike "Ordinarily, excluding exceptional circumstances," and striking "it will be accepted by." Change "the matter will be referred to the Presiding Minister of Presbytery" to "the Presiding Minister of Presbytery will be informed."

Andrew Richardson **proposed an amendment** to strike the sentences beginning from "An elder should be above reproach" to the sentence beginning "While acknowledging that if the Lord." Amended proposal read as follows:

• The CREC affirms the need for all officers to meet the biblical qualifications for office. (1 Tim. 3:1-7, Tit. 1:6-9). (1 Tim. 3:8-10, 12). While acknowledging that if the Lord marked iniquities no one would stand perfect, it is nevertheless important to uphold the qualifications as revealed in Scripture. An officer whose marriage has failed or whose child in his household is excommunicated will offer his resignation to the session (1 Tim. 3:4-5, Tit. 1:6). When an officer remains in office after one of these events (or similar), the Presiding Minister of Presbytery will be informed with a brief written description of the reasons in accordance with Article IV.D.2. The presbytery will respond to this report as appropriate. The local session is not judicially bound by the response of presbytery. If the presbytery recommends the officer's resignation and the local session does not abide by the presbytery recommendation, then the presbytery may or may not initiate proceedings according to Article IV.D.5.

Motion to amend proposal passed without objection. (Note: all three motions were received as friendly amendments and accepted by the one making the original motion as well as the one who seconded.)

Motion failed. 7 in favor, 10 opposed, 3 abstentions.

XII. Presiding Minister of Council (Pastor Hurt) Report

Motion - Andrew Richardson moved to approve both actions. Oleksandr Orlov-Koshchavka seconded. **Motion passed unanimously.**

Procedures Committee was present and heard the suggestion from Gabe Wetmore and the opinions of the

presbytery.

Proposal for Compensation of PMoC - Appendix H: There was a general agreement among presbytery

that this was a good idea. Brett Baker wanted to clarify that this compensation be thought of as a

reimbursement, or anticipated expenses, because compensation implies a paid employee.

XIV. Miscellaneous

Motion - Brett Baker moved that Yavor Rusinov be publicly recognized for his work on behalf of Anselm

Presbytery. Gary Barnard seconded.

Motion passed unanimously.

Motion - Brett Baker moved to publicly recognize and thank Dave Hatcher for his work as Presiding

Minister. Michael Kloss seconded.

Motion passed unanimously.
