- 1. Interview and Church Report
 - a) Christ Reformed has two members of their session; both paedobaptist and paedocommunion
 - b) Reformed Evangelical Statement
 - c) Hybrid of baptist views
 - d) Wrote a constitution
 - e) No objections to CREC statements.
- 2. Christ Reformed, Oakland ME, Matthew Gonnella moved to receive Christ the King Church, Belfast ME, Rev. Garrett Soucy as a member church in the Augustine Presbytery of the CREC. The motion carried unanimously.
- 3. Vows were administered to the delegates of Christ the King Church and they were recognized as a member church of the CREC. (Note: new member delegates may participate in discussion, but not vote in the meeting in which they are received.)
- B. Sand Hills Presbyterian Church, Southern Pines, NC
 - 1. Providence Church, David Cooper, Lynchburg moved to recommend Sand Hills Presbyterian, Pastor Kevin Skogan, Southern Pines, NC as a candidate church in the Augustine Presbytery of the CREC. The motion carried unanimously.
 - 2. (Note: candidate churches may be approved as member churches at the next stated meeting of the presbytery.)

IV. Augustine Presbytery Examinations

- A. Presbytery Examinations: Dan Nash, Matthew Corey
 - 1. Augustine Presbytery Examination Committee (2021): Matt Gonella (chair), Rev. Rick Davis, Rev. Jody Van Dyke (not able to be present), Rev. Michael Foster, and Garrett Soucy.
 - a) The Committee moved to sustain Mr. Nash's and Mr. Corey's ordination examination and recommend ordination to Christ Reformed Evangelical Church and Christ the King Church, respectively.
 - b) Vows are ordinarily administered directly by the local session but may be administered by presbytery upon the request and authorization of the local session (see Appendix B: Book of Procedures).
 - (1) PM Strawbridge administered the vows from the Book of Procedures to Mr. Nash, but not Mr. Corey. Mr. Corey's vows were taken in his congregational ordination service (5/16/2021) in Belfast, ME with PM Strawbridge (and Garrett Soucy) participating.
