2020/09/24:2 Mike Kloss moved that PM appoint 3 persons to a committee to write Anselm version of the amendment. Troy Martin Seconded. Carried unanimously. 90 days to deliver product to the PM (which would be December 23, 2020).

- 3. Brett Baker counted the votes. The vote tally was Hatcher: 16, Phelps: 10, Owen: 5. Dave Hatcher and Jack Phelps are appointed as delegates to Council. Jerry Owen is appointed the alternate delegate.
